Rationale

- Updated guidance from the Charity Commission
- Change of name of ACP -> UKSMO
- Change of objectives
- Clear role of a trustee and increase in number
- Clarity of governance procedures
- Procedures for removal of member, committee member, trustee
- Policies for Executive members
- Conflict of interest declaration
- Code of conduct for committee members and disciplinary procedures

New name

- Change of name for the society requires that the constitution is revised
- Opportunity to improve the governance processes and procedures
- Review the objectives of the organisation (requires CC approval)

Objectives

- Cancer care and the provision of cancer services in the UK for the benefit of patients
- Cancer education and training, including maintaining the skills of the workforce in new and novel therapies and mentoring for career development, and supporting professional development
- Research and innovation, encouraging collaborative and coordinated working
- Facilitating a forum to share expertise between members
- Providing a voice for medical oncologists to help shape the future of patient-centred cancer care and be a representative stakeholder to the Government, DHSC and NHS

Trustees

- Trustees of the Society shall include an independent chair and deputy chair (likely retired Ordinary Members or past Chairs of the Society)
- Also include the executive officers of the Committee and the President of the Society
- All trustees must demonstrate that they remain in good standing at all times

Trustees

The Trustees collectively will have legal duties and should:

- Ensure the charity works towards its purposes for public benefit
- Comply with the law and governing document
- Act in the charity's best interests
- Manage resources responsibly
- Act with reasonable care and skill
- Ensure accountability

Trustees responsibility

- **Strategic direction:** setting the vision, mission, core values and long-term strategy
- **Governance & compliance:** Ensuring the Society follows its constitution, relevant laws, and regulations, and maintains proper financial oversight
- **Financial stewardship:** Ensuring resources are used effectively for the charitable purpose, overseeing budgets, and maintaining financial security
- **Accountability:** Being ultimately accountable for the Society's performance and ensuring it meets its objectives. The Trustees shall oversee all matters relating to disciplinary procedures and will contribute to a disciplinary panel as deemed appropriate
- **Leadership:** Supporting the Committee and executive officers, providing challenge and advice
- **Fiduciary Duty:** Acting in the best interests of the Society and its beneficiaries, with integrity and avoiding conflicts of interest

Processes defined

- Appointment of Executive officers and President
- Ordinary members granted automatic membership, honorary and overseas
- Disqualification and removal of trustees and committee members
- Dissolution of the society
- Running of the executive committee
- Additional designated roles

Executive committee

- The Committee should be representative of the interests of the members and consist of the Chair, Deputy Chair, Secretary, Treasurer, Society Secretariat and additional ordinary members in designated roles and regional representatives

Additional designated roles

- **Strategy Lead** – responsible for developing and maintaining any strategy policies and documents relating to the objectives of the Society (as outlined in Rule 2)
- **Policy Lead** – responsible for leading the development and advocacy for policies related to cancer research, prevention, and patient care, by building relationships with government, charities, patient groups, and other stakeholders
- **Events Lead** – responsible for arrangements of any scientific meetings and liaison with other relevant meetings as required
- **Website / Communications Lead**
- **Resilience and Burnout Lead**

Ex Officio Committee members

- Training Lead (SAC Chair or nominated deputy)
- UK SACT Board representative
- UK Acute Oncology Society representative
- ESMO representative
- Chair of Joint Specialty Committee for Medical Oncology
- Chair of NHS England Chemotherapy Clinical Reference Group or equivalent
- Chair of the Early Career Consultants Committee of the Society
- Chair and up to two other representatives of the Residents Group of the Society

Regional representatives

- **Regional representatives** – the number of which and regional boundaries will be determined by the Committee, but likely to include representatives of each of the Nations of the United Kingdom and the five regions of England, namely:
 - South
 - London
 - Midlands
 - North East
 - North West
 - Scotland
 - Northern Ireland
 - Wales

- Confidentiality: responding to criticism in the media, see GMC guidance
- Leadership and management for all doctors, see GMC guidance
- Conflict of interest policy (requiring all committee members for complete an annual Conflict of Interest and Code of Conduct Declaration Form)
- Disciplinary procedures for UKSMO

- 1 post vacant at KSS deanery
- Likely to run a regular Round 3



Recent activities and achievements

- Trainee weekend, with Precision Oncology as theme, 21-22 November 2024, Leeds, over 100 registered with excellent feedback
- Planning for joint meeting with new consultants in April 2026
- Regular recruitment webinars with very high attendance- contributing to excellent recent application numbers and fill rates
- Curriculum videos explaining how to evidence curriculum- due to be published later this year
- National trainees survey, last published in 2020- repeated in 2025, with over 100 responses; final report due to be published and presented at April meeting
- New resources on website for current trainees- for international medical graduates, LTFT working, and out of programme activities
- Ongoing webinar series
- Revamp of recruitment website



ACP Mentorship Scheme

- Eligibility criteria:
 - Registrars on Medical Oncology training programme, preference given to ST5+;
 - Early-career consultants within 5 years of CCT.
- Mentor/mentee pairs allocated in summer 2025: **62 pairs**.
- Wide variety of focusses for mentorship programme expressed by mentees: clinical, academic, leadership, education.
- Suggested frequency of meetings: **at least quarterly**.
- Mostly remotely run, but approximately 20% of pairs report there will be some face-to-face interaction.
- Early timepoint (30 days) anonymous feedback collected:
 - Majority have had or have scheduled introductory meeting;
 - Small proportion of mentees (~10%) reported difficulties scheduling meetings;
 - A minority of mentors (~15%) reported no contact from allocated mentee;
- Mid-programme (6 months) feedback survey coming up soon.
